Eligibility Requirements for Senior Discount Program:

1. Applicant must be 62 years of age or older.
2. The property tax bill must be in applicant's name or spouse's name.
3. Applicant must be sole user of the facilities, except for your spouse and/or legal dependant.
4. Applicant's maximum household gross income cannot exceed:

Gross income includes social security and other income from all members of the household. If you are eligible to apply, please **complete** and **sign** page two of this application form, **attach** copies of your proof of age and your proof of income, and **return** the application by **June 30, 2020**.

Any of the following documents will be accepted as proof of age:

1. Birth Certificate
2. Medicare Card
3. Social Security Administration document verifying monthly payments.

Proof of age must be provided with your **first** application. Subsequent annual applications need only include proof of income.

Any of the following documents will be accepted as proof of income:

1. PG&E bill showing California Alternate Rates for Energy (CARE) program discount.
2. Letter from Community Services & Development showing SMUD (Sacramento Municipal Utility District) discount.
3. Federal Income Tax Return(s) for **2019** with total pension and annuities and Social Security Benefit taxable and non-taxable information. If this information is not filled in on the form, send copies of FORM SSA-1099, Social Security Benefit Statement, and Form(s) 1099-R for pension information. If legal dependent or spouse files separately, send a copy of their current return(s).

If you are not required to file an income tax return, copies of Form SSA-1099, 1099Z or other document verifying income, please sign below to certify the following statement:
