

## Marin Wildfire Prevention Authority (Measure C)

***This application serves to request Measure C - Marin Wildfire Prevention Authority Low-Income Senior Exemption for 2023-2024. An exemption application must be filed annually.***

**Low Income Senior Exemption** - The special parcel tax shall not be imposed upon any low-income owner, age sixty-five (65) years and over as of July 1 of each applicable Fiscal Year, of a parcel used solely for owner-occupied, single-family residential purposes, if the owner obtains an annual exemption to the special tax upon approval of the Marin Wildfire Prevention Authority. Low-income means the parcel owner's income is equal to or lower than the U.S. Department of Housing and Urban Development (HUD) income limits used to determine eligibility for assisted housing programs as set forth in the San Francisco, California HUD Metro FMR Area rates published annually. Mobile and floating homes are exempt from the special parcel tax and do not require an exemption application to be submitted.

To qualify for a Senior Low-Income Exemption for an owner-occupied, single family residence (house, condo, townhome), you must be **65 years of age or older by July 1, 2023**, and earn a total annual household income, calculated on number of people in household, less than:

1 Person \$104,400      2 People \$119,300      3 People \$134,200      4 People \$149,100      5 People \$161,050

**Applications must be postmarked on or before June 30, 2023.** If your application cannot be processed, you will be notified in writing, or via telephone call, explaining the reason and requesting the necessary information needed to process your application. If there are no issues with your application, you will not be contacted.
